Dividends

Dividend policy

Quilter will target a dividend pay-out ratio of 40% to 60% of post-tax operating profits, taking into account the underlying cash generation, cash resources, capital position, distributable reserves and market conditions at the time.

When will Quilter pay dividends?

We plan to announce dividends at the same time as the half year and full year results, with the first dividend planned in respect of our 2018 year end results.

How will I receive my dividend?

For your security, Quilter plc will only pay your dividend to the bank account currently registered with Link Market Services. Any election you made on your Old Mutual plc shares will be applied to your Quilter plc shareholding. To register your bank details please contact Link Market Services using the contact details on page 7.

Dividend currency

All dividends will be declared in pounds Sterling for shareholders on the UK share register and Rand for shareholders on the South African register. The foreign exchange rate will be determined the day before the Directors declare the dividend.

For shareholders on the registers in Malawi, Namibia and Zimbabwe the custodian will pay your dividend in your local curency using the foreign exchange rate on the day the dividend is paid.

Keeping your personal information up to date

It is important that you keep the personal information we hold up to date. That way correspondence advising you of any changes that might affect your shareholding reaches you and any dividends are paid to you promptly. You can do this using the shareholder helpline, in person or by post.

Historic share information

If you held shares in Old Mutual plc and have any questions about your holding or any unclaimed dividends, you should contact Link Market Services using the contact details on page 7. You will need your new Quilter Shareholder Reference Number to hand.

Buying and selling your Quilter shares

If you wish to buy or sell Quilter shares you can contact our Registrars. The value of shares can go up or down and you should seek independent financial advice.

Duplicate documents

If you have received more than one copy of Quilter shareholder documents you may have duplicate shareholder accounts. Please contact our Registrars who will be able to confirm and if necessary amalgamate any duplicate holdings.
